Winter Break is a great time to file your FAFSA! Students hoping to receive financial aid in the form of scholarships or loans should complete the Free Application for Federal Student Aid (FAFSA) each year before the **February 1st priority deadline** to be considered for all available aid.

P4's - Pre-NAPLEX Vouchers

To assist in your preparations for the NAPLEX and MPJE examinations, the College of Pharmacy will pay for all fourth-year students to take one Pre-NAPLEX Practice Exam offered by NABP.

You will receive a voucher number, which will serve as the form of payment during your online registration

for Pre-NAPLEX. The vouchers will be valid for one year and will specify expiration date.
